Explanation:

- 1 Indicates Year for which taxes are being paid
- 2 Warrant Date is the date upon which collection of taxes was authorized
- 3 The number identifying the municipality in which the parcel is located within the state. The first two numbers indicate the County; the last four numbers indicate the city, town, or village.
- 4 Property's identification number on the tax map
- 5 Street address of the property
- 6 School district in which parcel is located
- 7 Numerical code representing the classification of type of property
- 8 Roll Section 1 is the taxable section of the assessment roll
- 9 Indicates amount of acreage included with the property
- 10 Indicates: (a) the full market value of the property; (b) the total assessed value of the property (on which taxes are based) determined by the locality's assessor and (c) the level of assessment.
- 11 Indicates exemptions received and the value of the exemptions
- 12 Indicates various levies (levy = amount needed to be raised through the collection of taxes)
- 13 Special districts serving the property
- 14 Collection of unpaid 2015 taxes (relevies) covered by the county (eg. School, water, sewer, village)
- 15 Amount represents Assessed value less exemption(s) value
- 16 Taxpayer's share of the levy for each taxing purpose
- 17 Payment and penalties if bill is not paid
- 18 Total taxes due
- 19 Numerical code representing bank where escrow is held, if any
