

Stillwater Brown's Beach Rules and Regulations for Beach

- A. Hours of Operation. The hours of operation of the beach shall not be earlier than 11:00 am or later than 7: pm.
- B. Parking in designated areas ONLY.
- C. Picnicking: Is allowed in designated areas. Patrons must provide Self clean-up in all areas.
- D. Swimming and Conduct: No one under the age of eight (8) years shall use the beach unless accompanied by a person fourteen (14) years old or over. Children under the age of eight (8) must be accompanied in the water by a mature responsible adult who has swimming ability. Swimming is an authorized activity only when the lifeguard or attendant is on duty. Swimming is allowed inside the rope and float perimeter only. The lifeguard or attendant, when on duty, assumes responsibility for the safety and operation of the beach. The lifeguard or attendant has the authority to expel a user from the beach area for breach of safety of conduct that he or she deems contrary to the welfare of other users.
- E. Safety equipment and furniture must not be altered, moved or used by unauthorized persons.
- F. Emergency signals by load speaker device or whistle must be observed. Swimmers must leave swimming areas immediately upon signal or request of lifeguard or attendant. Patrons may not use whistles.
- G. People under the influence of alcohol or narcotics are prohibited from using the beach.
- H. Glass bottles or items (other than sunglasses), sticks, stones, or any object which is not part of regular beach equipment items, are not allowed in the swimming or beach area.
- I. Abusive or foul language is prohibited.
- J. Flotation devices: Only personally attached swimming devices, such as arm and waist flotation devices, are allowed with adult supervision.
- K. No domestic animals, leashed or otherwise, allowed within the beach designated area.
- L. No launching or docking of boats (of any kind) allowed in or around beach area.

- M. No fishing will be allowed in the beach area.
- N. No playing any ball game or other games that may disturb users of the beach or swimming area.
- O. The Beach area is not a refuse collection area. The refuse containers are for ordinary park litter only. Each user assumes the responsibility of not creating litter. The public is not allowed to use the refuse containers for home garbage.

Town Beach Passes:

Season Passes for Town Residents:

Adult- \$40

Children- \$20 (ages 5-11) Under 5 years-Free

Season pass holders will be issued Identification (ID) cards. Identification (ID) cards are not transferable. Proof of residency requirements will be necessary.

Day Admission: (All prices apply to walk-ins as well)

Town Resident per person for buses or passenger vans

Scheduled Bus group \$10 per visit not including per person fee.

(\$10 for bus and per person fee applies to all bussed in visitors outside of Stillwater and Malta.

Adults: \$5 ages 12 thru Adult

Children: \$3 ages 5-11 under 5 free

Proof of residency shall be as follows:

- 1. Personal visit to Town Hall, not phone call or mail.**
- 2. Property tax receipt or rental receipt from landlord.**
- 3. Driver's license or other picture ID**
- 4. Children under sixteen (16) must be accompanied by parent or guardian to secure card and parent or guardian must prove residency.**
- 5. Each person 16 and over in household must have ID card.**
